THE CENTER PROVIDED MEDICAL RECOVERY PROGRAM SERVICES TO 120 HOMELESS INDIVIDUALS. 77% OF THOSE DISCHARGED ENTERED PERMANENT HOUSING, TREATMENT OR SPECIALTY PROGRAMS, OR OTHER STABLE ENVIRONMENTS. THE CENTER ALSO ADDRESSED MENTAL HEALTH AND SUBSTANCE ABUSE NEEDS. NEARLY 40% OF CENTER CLIENTS WERE ALCOHOL-DEPENDENT, WHILE 30% WERE DRUG-DEPENDENT. MENTAL ILLNESS OR DEVELOPMENTAL DISABILITIES AFFECTED AN ADDITIONAL 34%.
